# COVID Vulnerabilities in Morris County



#### VULNERABLE POPULATIONS IN MORRIS COUNTY, NJ Background

The CDC advises that certain characteristics like age, gender, and income can influence a person's risk factors for contracting and becoming seriously ill from COVID-19. The list includes but is not limited to older adults, people with pre-existing health conditions, those living or working in congregate settings or high-density areas, those with limited English proficiency, pregnant, breastfeeding, or caring for a newborn, people experiencing homelessness, refugee populations, and those living in rural communities.

The information and data presented in this social support manual defines those residents living in Morris County who are more at-risk for contracting COVID-19 and informs the development of a community resource manual for the Morris County Division of Public Health. The purpose of this manual is to develop and foster connections with social service providers and community stakeholders in support of local health departments who are providing targeted outreach to COVID-exposed and COVID-positive residents within their jurisdictions.

#### COVID-19 Vulnerability in Morris County

The following categories of vulnerable populations are living in Morris County: Residents aged 65 and over, those with limited English proficiency, those living in congregate settings or densely populated areas, uninsured/under-insured, residents living in poverty or just above the Federal Poverty Line, the unemployed, those with poor health status, those suffering from substance use and/or mental illness, migrants, and the homeless. Below are the geographic locations where high concentrations of vulnerable residents reside.


#### Population Age 65+

The CDC reports that 8 out of 10 COVID-19 documented deaths have been in adults 65 years and older. Compared to younger adults, they are more likely to require hospitalization if they contract COVID-19 (Source: CDC.gov).


#### Population with Limited English Proficiency

The inability to speak or understand English creates a barrier in receiving equitable health care. Barriers include lack of communication regarding COVID-19 resources, lack of access to healthcare, and lack of health literacy that informs about protection against COVID-19 and information on testing and vaccination. This indicator reports that 8.41% of Morris County residents age 5+ speak English less than "very well".

#### **Total Population/Population Density**

According to the U.S. Census Bureau American Community Survey 2015-19 five-year estimates, a total of 493,379 people live in the 460.56 square mile report area defined for this assessment. Residential overcrowding makes social distancing difficult and can increase the risk of exposure to COVID-19.

#### **Uninsured Population**

The lack of health insurance is considered a key driver of health status. Uninsured residents experience financial barriers in receiving medical care and screening measures for prevention of disease, and often delay seeking care when sick. When they do seek care, they often receive less care due to inability to pay.

**Table Four:** While most residents in Morris County have health insurance, there are areas where over 20% of residents do not have insurance. Tract 448 and 450 in Dover accounted for 28%; Victory Gardens tract 456.02 accounted for 23%; and Tract 435 in Morristown accounted for 25%. In sections of Parsippany, Mt. Arlington and Netcong, nearly 11% of the population is uninsured.

#### **Broadband Access**

While 97% of Morris County residents have access to high-speed internet access, there are areas with deficits. Residents with little to no access to the internet lack access to information that can help protect them from contracting COVID-19, provide information about testing sites, and information about vaccine safety and where to get vaccinated.

**Table Five:** Sections of Parsippany-Troy Hills (i.e. Lake Hiawatha) and Victory Gardens are lacking access to high-speed internet. Other areas of concern are rural sections of Jefferson and Chester Township.

#### Substance Use

The 2020 Morris County Substance Abuse Overview has not yet been released, however there is anecdotal information that alcohol and drug use has significantly increased since the pandemic began. Alcohol and other drugs suppress the immune system; therefore users are more susceptible to contracting COVID-19 and experiencing more severe effects of the virus.

While we do not have the data for alcohol related deaths in 2020, drug overdoses have spiked in NJ and led to a surge of overdoses in Morris County. Suspected drug related deaths went from 86 deaths in 2019, to 99 deaths in 2020. As of February 28, 2021, there have been 17 suspected drug related deaths putting Morris County on track for 102 overdose deaths in 2021. (Source: State.nj.us: Department of Health/Population Health). Despite multi-faceted challenges posed by COVID-19 making it harder to access treatment, the need for accessibility is high.

#### Population in Poverty (100% FPL)

Poverty is considered a key driver of health status. Within the report area, 4.78% of individuals are living in households with income below the Federal Poverty Level (FPL). Poverty creates barriers accessing health services, healthy food, and other necessities that contribute to poor health status and puts residents at increased risk of contracting COVID-19.

#### Homelessness

The homeless are considered one of the most vulnerable groups of people to be impacted by COVID-19. The inability to safely isolate from others, poor access to hand washing and hygiene, lack of access to masks, poor nutrition, and underlying medical conditions makes homeless people at increased risk of contracting COVID-19 and severe illness.

Morris County reported 243 households experiencing homelessness for a total of 354 individuals homeless, according to a count on the night of January 28, 2000. Of those residents counted, 51 persons were identified as chronically homeless and 29 were not sheltered on the night of the count. #### United for A.L.I.C.E. What is it and why is it important?

**A.L.I.C.E.** is an acronym for <u>Asset Limited</u>, <u>Income Constrained</u>, <u>Employed</u>. This is a way to describe and understand households in our communities that earn above the Federal Poverty Level (FPT). These households do not make enough money to afford the minimum basic essential items to thrive. The cost of living outpaces what they earn, and they struggle to meet essential needs like housing, food, transportation, childcare, health care, and technology. These families are forced to prioritize what bills will be paid, and which ones will go unpaid. They have to make choices between not seeking medical attention when needed, not paying for quality childcare and education for their children, or not paying the rent. One unexpected expense, like contracting a serious illness, can push this population into financial crisis. ALICE households are vulnerable to poor economic and health outcomes making them more susceptible to COVID-19. Below is the A.L.I.C.E. data for Morris County from 2018. While this data is prior to the pandemic, we can surmise that this population has been hard hit by the pandemic.

#### Social Vulnerability Index (SVI)

The CDC/ATSDR Social Vulnerability Index is a tool that uses U.S. Census data to determine the social vulnerability of every census tract. ATSDR's Geospatial Research, Analysis & Services Program (GRASP) maintains the CDC/ATSDR SVI to help public health officials better prepare for and respond to emergency events like disease outbreaks such as COVID-19 and other disasters. A percentile ranking represents the proportion of tracts (or counties) that are equal to or lower than a tract (or county) of interest in terms of social interest. For example, a SVI ranking of 0.85 signifies that 85% of tracts (or counties) in the state or nation are less vulnerable than the tract (or county) of interest and that 15% of tracts (or counties) in the state or nation are more vulnerable.

The degree to which a community exhibits certain social conditions, including high poverty, low percentage of vehicle access, or crowded households may affect the community's ability to prevent human suffering and financial loss in the event of disaster and describes a community's social vulnerability. A higher score indicates increased vulnerability. Morris County has a social vulnerability index score of 0.12, which is less than the state average of 0.44.

## Key Findings



#### **Key Findings**

Based on interviews, email communications, and conversations with "boots on the ground" social service agents, vulnerable population outreach coordinators, and health educators the following themes related to COVID-19 vulnerability emerged: access to food and basic essentials, housing, linguistic isolation, transportation & access to healthcare, and mental health/substance use (including children, adults & seniors).

#### Food & Basic Needs Assistance

Individuals and families while in isolation and quarantine after exposure to or acquiring COVID-19 have experienced difficulty in accessing food due to social isolation from friends and family, lack of support systems, and an inability to afford or access food delivery services.

Morris County Office of Temporary Assistance (OTA)	Reported a slight increase in applications for SNAP and General Assistance during the pandemic.
Nourish NJ is a non-profit organization that provides food assistance (farmers market & soup kitchen) and wrap-around social services, including provisions for housing, employment, mental/substance use, & case management to residents of Morris County.	Nourish NJ has seen a 30% increase in individuals and families seeking food assistance and help with essential supplies and services. Remaining open every day of the pandemic for takeout meals and support services, they also mobilized their services to include food delivery to residents in isolation & quarantine and provide daily food and services to those that have the ability to go to their Morristown location. They have resumed their free farmers markets that were forced to close during the pandemic. They serve all Morris County residents, but report the highest need areas are in Dover, Morristown, and Parsippany.
Food Pantries have been forced to reduce hours and/or provide services by appointment only or for outdoor pickup. Some pantries will deliver to residents in their home municipality and surrounding areas.	The Rockaway Food Pantry and Faith Kitchen in Dover report slight increases in those they've served. Both locations have new individuals & families they had not served prior to the pandemic and the majority are individuals who lost employment and need help with food and basic needs.
Mutual Morris is a community organized mutual aid group with over 100 volunteers that help Morris County residents with food, basic needs, and referrals to social services.	Mutual Morris has provided a lifeline to over 700 individuals and families who have been impacted by illness or economic fallout due to the pandemic. They purchase and deliver food, diapers, toiletries, medicine & other essentials to individuals and families in need. They also connect families to social services to help pay for rent and utilities. They report rental assistance as being the biggest need, with entire families living in single rooms with no access to kitchens because they can't afford it. They serve all of Morris County, but areas of highest need are Dover and Morristown.

#### Housing

Severe housing problems include overcrowding determined by the number of persons per room, bedroom, or square footage; severe housing cost burden; and lack of kitchen and/or plumbing facilities. Morris county residents living below the Federal Poverty Level and A.L.I.C.E. households are especially vulnerable due to job loss, inability to work during isolation and quarantine, and/or severe illness.

Mutual Morris	While the majority of individuals and families are initially connected to Mutual Morris for help with food and basic necessities, many also ask for rental assistance. They report families living in one room apartments with no kitchen access because they can't afford it. Many of them owe thousands of dollars in back rent due to inability to pay because they have become unemployed during the pandemic.
Vulnerable Population Outreach Coordinators and Contact Tracers	There are a few sections in the county where individuals and families are experiencing residential overcrowding making it difficult and/or impossible to social distance. Individuals and families are living together in small spaces in Dover and Morristown. Migrant workers are living in dorm style housing at farm sites in some regions of Washington and Chester Township.
Legal Services of Northwest Jersey	According to David Saltzman, an attorney from Legal Services of Northwest NJ, the NJ Judiciary estimates there will be nearly 194k evictions across all NJ counites over the next two years. In any given year in Morris County there are typically 3,000 to 3,500 evictions. There is widespread concern about what will happen when the eviction moratorium is lifted, and individuals and families are required to pay back months and months of past due rent. Many fear there will be a title wave of eviction filings with the courts and people will be forced into homelessness.
Morris County Office of Temporary Assistance (OTA)	<ul> <li>OTA is advising residents to seek legal counsel and services well in advance of the deadline for the eviction moratorium. OTA operates the COVID Housing Assistance Program and in just the first few days of applications being accepted during Phase One, the Department of Community Affairs closed the portal due to overwhelming demand. Morris County saw approximately 80 applications and assisted in over 200k in rent and mortgage relief during Phase One.</li> <li>OTA reports the majority of Morris County homeless are in Dover and Morristown. The homeless are at high-risk for exposure to COVID-19 and becoming seriously ill from COVID-19. Many resources like drop-in centers, soup kitchens, and shelters completely closed in the beginning of the pandemic and are now operating at limited capacity.</li> </ul>

#### Linguistic Isolation

The inability to read, write, or speak English creates language barriers in receiving vital information about COVID-19 prevention, testing, and vaccination, inhibiting health literacy.

Vulnerable Population	More than half the population of Dover is Spanish speaking only.		
Outreach Coordinators	There is a small group of migrant workers in the Chester area that speak Mam, an oral-only language from a region in Guatemala and can't read. Finding information about this vulnerable group is difficult making them an extremely hard population to reach.		
	Language barriers in Victory Gardens and Butler due to Spanish speaking only.		
General	Difficulty finding information HUBS for non-English speakers in order to disseminate print and media information about COVID-19 and available resources.		
Mutual Morris	Identified locations in Morristown with Mam and Spanish speakers.		

#### Transportation

The lack of transportation creates barriers to accessing healthcare, and COVID-19 testing and vaccination. As of this writing, the state has contracted with Lyft to provide free transportation to vaccination sites for anyone, including those with collapsible wheelchairs. New Jersey Transit also provides free rides to and from vaccination sites.

Vulnerable Population	Migrant workers in Chester region are 15+ minutes away from the nearest Zufall Health Center and lack access to transportation services.	
Outreach Coordinators	Residents of Dover lack access to transportation, especially to testing and vaccination sites.	

#### Mental Health & Substance Use

Health Educators	There is an increase in demand for mental health and substance use services and resources for seniors. They are experiencing social isolation and loneliness from being confined to their homes or apartments which is increasing anxiety and depression. While virtual resources have been made available, often seniors are intimidated, unable, or dis-interested in participating in virtual platforms. Children and teens are isolated from friends and peers increasing their anxiety and loneliness. Virtual learning has increased academic stress for some students and teachers.
Vulnerable Population Outreach Coordinators	Under-served Seniors are having difficulty registering for and getting vaccination appointments and need extra help navigating on-line registration and finding locations for vaccinations. Special needs children need extra help and/or access to virtual services.
Mental Health Providers	Mental health needs and people seeking treatment have increased, while services have decreased and/or converted to telephone and telehealth services.
Substance Use Providers	There has been an increase in people seeking substance use treatment and support for their family members. There has been an increase in teen substance use with little or no school intervention due to virtual learning, leaving parents to cope with and deal with the problem at home. Individual have increased alcohol use due to job loss, boredom, and loneliness from being home during the pandemic.
